Dear Parents and Guardians,

Welcome everyone to a new year at Templestowe Valley Primary School. We are looking forward to working with you and your children throughout the year.

Start Up Program

At the beginning of the year, the teachers run a 'start up program' to help build relationships in the classroom. The students get to know each other and their teacher. They also learn the routines of the classroom and the expectations. The students will also start their curriculum including home reading and homework tasks.

Meet and Greet

Our meet and greet sessions will take place in Week 4 (Tuesday 17/2 and Thursday 19/2) from 3:40-6pm. Each parent will have a 10 minute slot with their teacher to talk about important information about their child. Bookings will open on Compass on Monday 2 February.

2026 Camps, Sports and Excursions Fund Applications

From 1 January 2026, families eligible for CSEF (**application form below**) will see an increase in support to \$400 for primary and secondary school children.

Criterion 1 – General eligibility

The applicant must be one of the following on the first student day of Term 1 (28 January 2026) or Term 2 (20 April 2026):

- a parent or carer who is the beneficiary of a financially means-tested card
- a student over 16 years who is considered a mature minor and holds a valid means-tested concession card (such as a Youth Allowance Health Care Card). For guidance on assessing whether a student is a mature minor, refer to the department's [Mature Minors and Decision Making policy](#)
- a parent or carer whose child is 16 or over and the beneficiary of a financially means-tested card but are not considered a mature minor.

If you are eligible and have not yet completed an application for 2026, please fill in the attached form and return to the office by no later than **19 FEBRUARY 2026 in order for funds to be processed asap**. Families can list more than one student in the one application form if they are attending the same school.

NB:- If you applied for CSEF at your child's school last year, you do not need to complete an application form this year unless there has been a change in your family circumstances. i.e.

- new student enrolments; your child has started or changed schools this year.
- changed family circumstances; such as a change of custody, change of name, concession card number, or new siblings commencing this year.

Just a reminder to parents to check the signs carefully when parking around our school. Please don't park in driveways or in No Standing zones. Declaration

I authorise the Victorian Department of Education (DE) to use Centrelink Confirmation eServices to perform an enquiry about my Centrelink customer details and concession card status to enable the business to determine if I qualify for a concession, rebate or service. I also authorise the Victorian Department of Families, Fairness and Housing (DFFH) to provide the results of any enquiry to DE regarding temporary care orders. I understand that:

- DFFH or Centrelink will use information I have provided to DE to confirm my eligibility for the Camps, Sports and Excursions Fund and will disclose to DE personal information including my name, address, payment and concession card type and status.
- This consent, once signed, remains valid while my child is enrolled at a registered Victorian school unless I withdraw it by contacting the school.
- I can obtain proof of my circumstances/details from DFFH and provide it to my child's school so that my eligibility for the Camps, Sports and Excursions Fund can be determined.
- If I withdraw my consent or do not alternatively provide proof of my circumstances/details, I may not be eligible for the Camps, Sports and Excursions Fund provided by DE.
- Information regarding my eligibility for the Camps, Sports and Excursions Fund may be disclosed to DFFH and/or State Schools Related for the purpose of evaluating concession card services or confirming eligibility for assistance.
- You can request access to the personal information that we hold about you, and to request that any errors be corrected, by contacting your child's school.
