YEAR 4 PARENT PAYMENT ARRANGEMENTS 2022

Dear Parents/Guardians,

Templestowe Valley Primary School is looking forward to another great year of teaching and learning and would like to advise you of Templestowe Valley's voluntary financial contributions for 2022.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all your support, whether that's through fundraising or volunteering your time. This has made a huge difference to our school and the programs we can offer.

Within our school this support has allowed us to organise and coordinate the best possible programs outside of the traditional teaching and learning classroom structure. These financial contributions assist us with the purchasing of art, music and physical education equipment and resources, which in turn, supports them to be exemplary programs coinciding with our elite classroom teaching of the established subjects such as Reading, Writing and Mathematics.

In the past TVPS have purchased book pack items in bulk on parents' behalf, due to changes in the Parent Payment Policy School Council have agreed that next year parents will purchase these directly through a third party. The Maxim Office Group are able to supply these book packs. They have provided student stationary items for a number of years, and when comparing suppliers the quality and pricing that they quoted lead them to be the most competitive. Book packs directly ordered through Maxim will be delivered to the school and will be able to be collected on **Thursday January 27th 2022**.

There will be no upfront lump payment for excursions in 2022. Excursions will be charged on a 'user pays' basis as they were for 2021. In order for a student to attend the excursion/incursion, it must be paid for by the due date before each event. The total cost per student will amount to approximately:

- Prep to Year 4 - \$120
- Years 5 and 6 - \$140

Department of Education guidelines now mandate that schools are UNABLE to provide parents with a statement of fees. Students in each of the different year levels will receive a notification via Compass for the recommended voluntary financial contribution specific to their year level.

We thank you for your continued support of the excellent educational opportunities we offer to your child.

2022 School Approved Contributions are available to pay on Compass from the **1st of January 2022** and is Templestowe Valley Primary School's preferred method of payment. Payments can also be made by cash or credit card.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions
Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions
Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities
Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).

FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
